Turkish migration to Europe and beyond over five decades resulted in strong minorities emerging in many countries. Sizeable Turkish communities have appeared in Germany, the Netherlands, Austria, Switzerland, and the UK. Dynamic nature of international human mobility and changing attitudes and policies towards immigration brought these diaspora populations under spot lights. In this book, the most recent research and scholarship on Turkish migration, identity issues and strategies and patterns of integration are gathered to offer a wide array of case studies with a multidisciplinary perspective. Tackling two key areas in migration scholarship, this book starts with mobility patterns of Turks in Europe before examining incentives for Turks to return home. Integration and identity processes and issues are investigated from multiple angles by several researchers. The thematic scope ranges from the uses of health services by refugees in London to patterns of child poverty among the movers in Sweden, and to racism, ethnic and religious identity, belonging and portrayal of migrants in movies. We do

hope this volume will be of use to the students, academics, researchers and practitioners in the field. There is a fast growing literature on Turkish migration and we aimed at laying another brick.

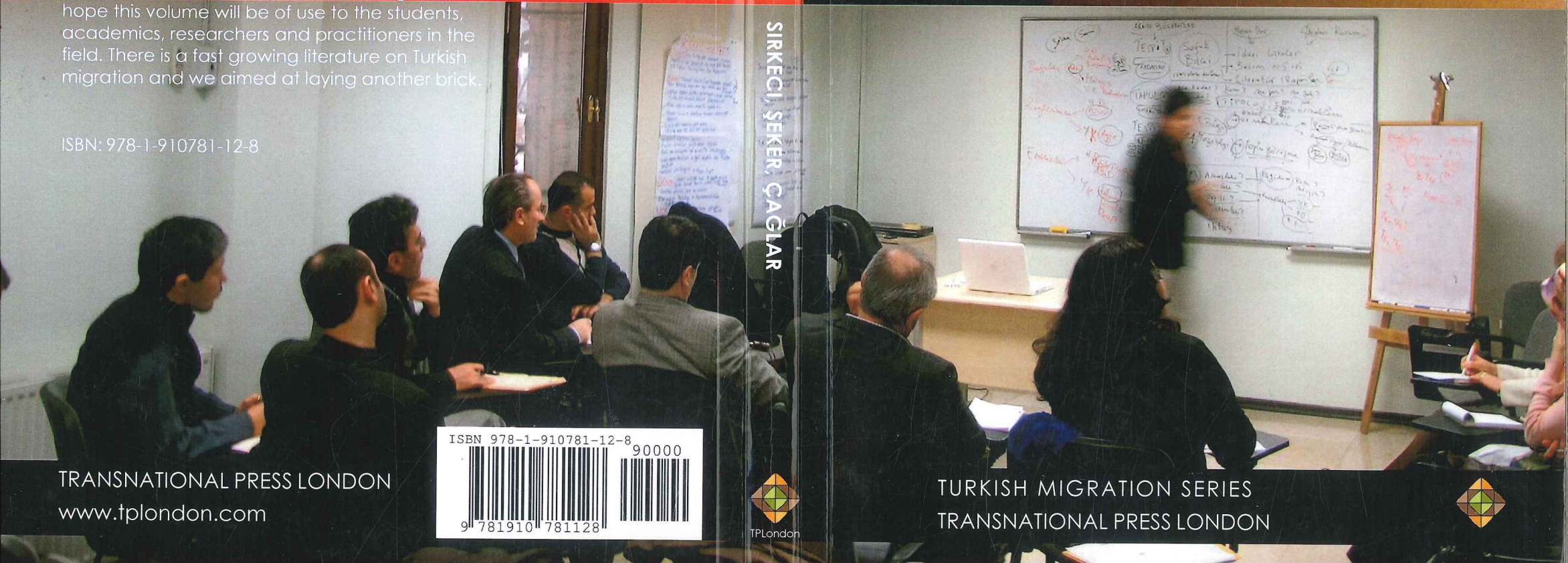
